Full Guidance on Building Control Charges

(Effective from 1st December 2008 – VAT @ 15%)

Please note that simplified Householder Guidance on Building Control Charges is also available on request.

The amount we charge varies depending on the type of work you intend to carry out, although the total amount which you pay will be the same whether you give us either Full Plans or a Building Notice. Guidance on deciding which type of application to submit is available on request. You should be able to calculate the charges payable by reference to the following notes and tables. Alternatively please try the automatic charge calculator available on our website. In case of difficulty, please do not hesitate to contact us.

Types of Application and Charge

Full Plans Applications

Charges are normally made in two stages. A **Plan Charge** is payable when you give us the application. This enables us to check the plans and hopefully approve them. Sometimes, because of insufficient information for example and the legal time limits we have for checking the plans, we have to reject them. However, if required information is then resubmitted, providing the plans are for substantially the same work, no further plan charge is usually required. When the work starts and we have carried out our first inspection, an **Inspection Charge** normally becomes payable. If applicable, you will be sent an invoice for a single payment and this will cover all necessary inspections. If you choose to, you can of course include the inspection charge with your payment of the plan charge at the time you give us the application.

Building Notices

The **Building Notice Charge** is payable in full before work starts and at the time you give us the Building Notice. This payment covers all the checks and site inspections we consider necessary relating to the work described in the notice.

Regularisation Applications -

An application for a Regularisation Certificate is a procedure available to owners of unauthorised building work which has been carried out since 1985. This is work which has been completed without a Building Regulation application ever having been made. The purpose is to enable people to apply to us retrospectively, asking for confirmation that the work complies with the Regulations. Further information is available on request. The **Regularisation Charge** is payable in full at the time the application is made and is 120% of the equivalent building notice charge, excluding VAT. No VAT is payable on Regularisation charges.

Reversion Applications -

When work under the supervision of a private sector building control body reverts to local authority control before satisfactory completion, a **Reversion Charge** is payable which is equal to the Building Notice Charge.

Charge Amounts

Charges vary depending on the type of the work to be carried out and are calculated by reference to the following tables. Please note that for some schemes, for example a small domestic extension with **separate** internal alterations, you will need to refer to two tables to calculate the total charge payable; Table 2 to check the charge for the extension and Table 3 to check the charge for the internal alterations.

Stage Payments - The regulations do allow us to agree the payment of charges by instalments. If your total charge payable exceeds £1000 and you would like us to arrange stage payments, please contact us.

VAT - is payable on all Building Control charges where the Local Authority is not the only authorised provider of Building Control services. With effect from the 1st December 2008 VAT has been applied to these charges @ 15%. VAT is payable in all cases except Regularisation Charges.

Exemptions/Refunds of Charges

Disabled People - Building work carried out to existing dwellings or to public buildings wholly for the purpose of providing access and/or facilities designed to secure the greater health, safety, welfare or convenience of disabled people, are exempt from charges. For these regulations, "disabled person" means a person who is within any of the descriptions of persons to whom section 29(1) of the National Assistance Act 1948 applies.

Refunds - Where a charge is paid but work does not proceed, any request for a refund will be considered on the basis of costs incurred by the Council subject to a minimum administration charge of £50.00.

Table 1- Charges for most Newly Built Houses and Flats

This table is used where the total new internal floor area of each new dwelling, excluding any garage or car port does not exceed 300m² and the building has no more than three storeys (each basement level being counted as one storey). In any other case, the charge is based on Table 3 and the total estimated cost of the work. Where new housing estates contain repetitive work, a reduction in the charges may apply. In these cases please contact us for advice.

Table 2 - Charges for Domestic Extensions and Garages less than 60m² floor area

Where the work involves more than one domestic extension, the total new floor area of all storeys of all extensions shown on the application must be added together to calculate the relevant charge. If part of the scheme includes work not associated with an extension, for example, the conversion of an existing garage to a habitable room, then the charge for this part should be calculated in accordance with Table 3 and added to the charge for the extension according to Table 2. If the total new floor area of the extension(s) exceed 60m² or 3 storeys in height then the charge is calculated according to Table 3 and the estimated cost of work.

Table 3 - Charges for Other Work (Not Covered by Tables 1 or 2)

This table deals with all other building work not covered by Tables 1 or 2. The total estimated cost means a reasonable estimate that would be charged by a person in business to carry out the work shown or described in the application. No allowance should therefore be made for own labour for example. The estimate should exclude VAT, land purchase costs, and any professional fees paid to an architect, engineer or surveyor etc.
