601pm Ltd is a hybrid of a cafe in the daytime and a bar in the evening. We provide food and desserts for customers to enjoy with the drinks. Our premises consist of two floors. The ground floor of the premises, our main area, is where customers can sit down and enjoy their food and drink. The upper floor has a pool table alongside two noise-proof rooms with karaoke systems. We aim to introduce and provide Korean-styled entertainment that is in-trend in South Korea, in the heart of New Malden. We hope our business can implement an entertaining but healthy culture.

Our current licensable hours are 10:00-23:00/00:00 (weekday/weekend). Due to the nature of the business, most of our customers consume their main meals elsewhere and visit our premises afterwards. Thus, our peak hours commence mainly during later at night. There have been many occasions when we had to turn our customers around and were not able to serve them because of the licensable/ opening hours. This has caused a downturn in our customer numbers and sales. We believe that through the extended opening/ licensable hours, we will be able to accommodate more customers, providing services for them. This will not only promote our sales but will bring a positive impact on the diversity of night leisure within the neighbourhood, as well as the economy of the Royal Borough of Kingston.

We are seeking to extend the licensed area to the first floor as shown by the plan submitted with this application.

M Describe any additional steps you intend to take to promote the four licensing objectives as a result of the proposed variation:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)

- Prior 30 minutes to our closing hours, we will clearly notify our customers of our opening hours and make sure that they finish their drinks before leaving the premises. This will ensure that customers who are yet to order do not rush in finishing their new drinks and become too drunk.
- Similarly, we will not serve drinks to those who are already too drunk from drinking.
- We will regularly monitor the conditions of our sound-proof walls, to reduce the nuisance that could cause in the neighbourhood.

b) The prevention of crime and disorder

- All our drinks will be stored in refrigerator that is located behind the bar, where customers are prohibited from entering.
- If the customer ordering drinks already looks drunk, we will refuse their orders and not serve any more drinks to them.

c) Public safety

- We will not tolerate any actions that puts our employees, customers and the neighbours at risk.
- For the safety of our customers, if anyone drunk causes nuisance in the restaurant, we will kindly ask them to leave the premises, as soon as possible.
- Moreover, we will dispose the empty bottles only inside the designated dumpster, that is located behind the premises.

d) The prevention of public nuisance

- Our premises is located closely to the neighbourhood. Thus, from 21:30, we will politely ask our customers to leave the premises quietly and not to cause nuisance in the neighbourhood.
- We will regularly monitor the condition of the soundproof walls in the karaoke rooms, so minimal sound nuisance is caused in the neighbourhood.

e) The protection of children from harm

Our staffs will strictly abide to the “Challenge 25” rule.
We will not supply alcohol to those who look under 25, do not hold their ID on them.



Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.

 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community

premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
