

## ROYAL BOROUGH OF KINGSTON UPON THAMES

### CONTROLLED PARKING ZONE AMENDMENTS PARKING PERMIT CHARGES AND CONDITIONS

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames propose to make the following Order under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:

- The Kingston upon Thames (Parking Places) (Amendment No. \*) Order 20\*\*.

2. The general effects of the Order, in line with the Council's Notices of Variation (to increase off-street and on-street parking charges), would be to amend certain provisions of the Orders listed in the Schedule to this Notice as follows;

- (a) to introduce new criteria when applying for Business Parking Permits by allowing the following quantities:- 1 permit, '2 to 5' permits and '6 or more' permits (the current limit is 2 permits per business user);
- (b) to assign charges for the proposed quantities of Business Parking Permits as follows;

Quantity & Duration	Charge
1 permit – 1 year	£300
1 permit – 6 months	£180
1 permit – 3 months	£100
'2 to 5' permits – 1 year	£450
'2 to 5' permits – 6 months	£270
'2 to 5' permits – 3 months	£150
'6 or more' permits – 1 year	£675
'6 or more' permits – 6 months	£405
'6 or more' permits – 3 months	£225

- (c) to amend the conditions for the refund of unexpired Parking Permits so that a refund for a Business or Residents' Parking Permit be given for blocks of 3 complete months before the expiry date (currently, a refund is given for each complete month).

Please note:- Business Parking Permits will continue to be unavailable in Kingston Town (Zone A/A1).

3. The proposed Order and other documents giving more detailed particulars of the Order are available for inspection until 6 weeks have elapsed from the date on which either the Order is made or the Council decides not to make the Order at:

- The Information and Advice Centre, Guildhall 2, Kingston upon Thames, KT1 1EU between 8.00 a.m. and 6.00 p.m. on Mondays to Fridays inclusive;
- Hook & Chessington Library, The Hook Centre, Hook Road, Chessington during normal opening hours;
- Kingston Library, Fairfield Road, Kingston, during normal opening hours;
- New Malden Library, Sandal Road, New Malden, during normal opening hours;
- Old Malden Library, Church Road, Worcester Park, during normal opening hours;
- Surbiton Library, Ewell Road, Surbiton, during normal opening hours;

- Tolworth Community Library, 37–39 The Broadway, Tolworth, during normal opening hours; and
- Tudor Drive Library, Tudor Drive, Kingston during normal opening hours.

5.
