*The Kingston upon Thames (Off Street Parking Places) (Amendment No. 2) Traffic Order 2020*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames made the above-mentioned Order on 20<sup>th</sup> April 2020 under sections 32, 35, 124 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order, which will come into force on 27<sup>th</sup> April 2020, will be;
  - (a) in Blagdon Road multi-storey car park (New Malden), to update the opening and parking charging hours as follows:
    - (i) Opening hours; Monday to Saturday from 7:45 a.m. to 7:00 p.m.; and Sunday from 10:45 a.m. to 7:00 p.m.;
    - (ii) Parking charges (which will also apply on bank and public holidays); Monday to Saturday from 8:00 a.m. to 7:00 p.m.; and Sunday from 11:00 a.m. to 7:00 p.m.;
  - (b) to update the provisions to include the release fee of £50.00 for any vehicle when a multi-storey car park is closed and secure.
3. The Order and other documents giving more detailed particulars including plans showing the location and effect of the Order are available for inspection until 1<sup>st</sup> June 2020 at The Information and Advice Centre, Guildhall 2, Kingston upon Thames, KT1 1EU between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive.

5. Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or any relevant regulations made thereunder have not been complied with in relation to the Order may make application for the purpose to the High Court by 1<sup>st</sup> June 2020.

**Made :- 20<sup>th</sup> April 2020**

**Coming into force :- 27<sup>th</sup> April 2020**

The Council of the Royal Borough of Kingston upon Thames, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 32, 35, 124 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 **(a)** as amended and the Road Traffic Act 1991 **(b)** as amended and of all other enabling powers hereby makes the following Order: -

1. This Order shall come into force on 20<sup>th</sup> April 2020 and may be cited as the Kingston upon Thames (Off Street Parking Places) (Amendment No. 2) Traffic Order 2020.
2. In this Order:-
  - (1) "the Order of 2014" means the Kingston upon Thames (Off Street Parking Places) (No. 1) Order 2014 **(c)**;
  - (2) the expression "enactment" means any enactment, whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
  - (3) any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment.
3. (1) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2014 shall have effect as though;
  - (a) for the parking place in Schedule 1 to that Order named "BLAGDON ROAD CAR PARK, Cocks Crescent, New Malden" there were substituted the parking place similarly named and set out in Schedule 1 to this Order;

**(a)** 1984 c.27 **(b)** 1985 c.51 **(c)** RBK 2014/1

- (b) for the parking place in Schedule 2 to that Order named “BLAGDON ROAD CAR PARK, Cocks Crescent, New Malden” there were substituted the parking place similarly named and set out in Schedule 2 to this Order;
- (c) there were added to the Interpretation under Article 3 (1) of that order the following definition:-  
“**release fee**” in relation to a parking place means the fee mentioned in Article 17 (8);” and
- (d) for **Payment of Parking Charges** in Article 17 of that Order there were added the following item:-  
“(8) a release fee of £50.00 shall be payable for any vehicle to be retrieved when a multi-storey car park is closed and secure.”

(2) The relevant provisions of the Order of 2014 (as amended) shall apply to the parking places set out in Schedules 1 and 2 to this Order as though they were designated by that Order.

### **EXPLANATORY NOTE**

*(This Note is not part of the Order but is intended to indicate its general purport.)*

This Order amends the Kingston upon Thames (Off Street Parking Places) (No. 1) Order 2014 so as, in Blagdon Road multi-storey car park (New Malden), to update the opening and parking charging hours as follows:-

- Opening Hours:  
Monday to Saturday from 7.45am to 7.00pm; and Sunday from 10.45am to 7.00pm
- Parking Charges Hours:  
Monday to Saturday from 8.00pm to 7.00pm; and Sunday from 11.00am to 7.00pm
- Parking charges also apply on public and bank holidays
- to update the provisions to include the release fee of £50.00 for any vehicle when the multi-storey car parks are closed and secure.

**Parking charges:**

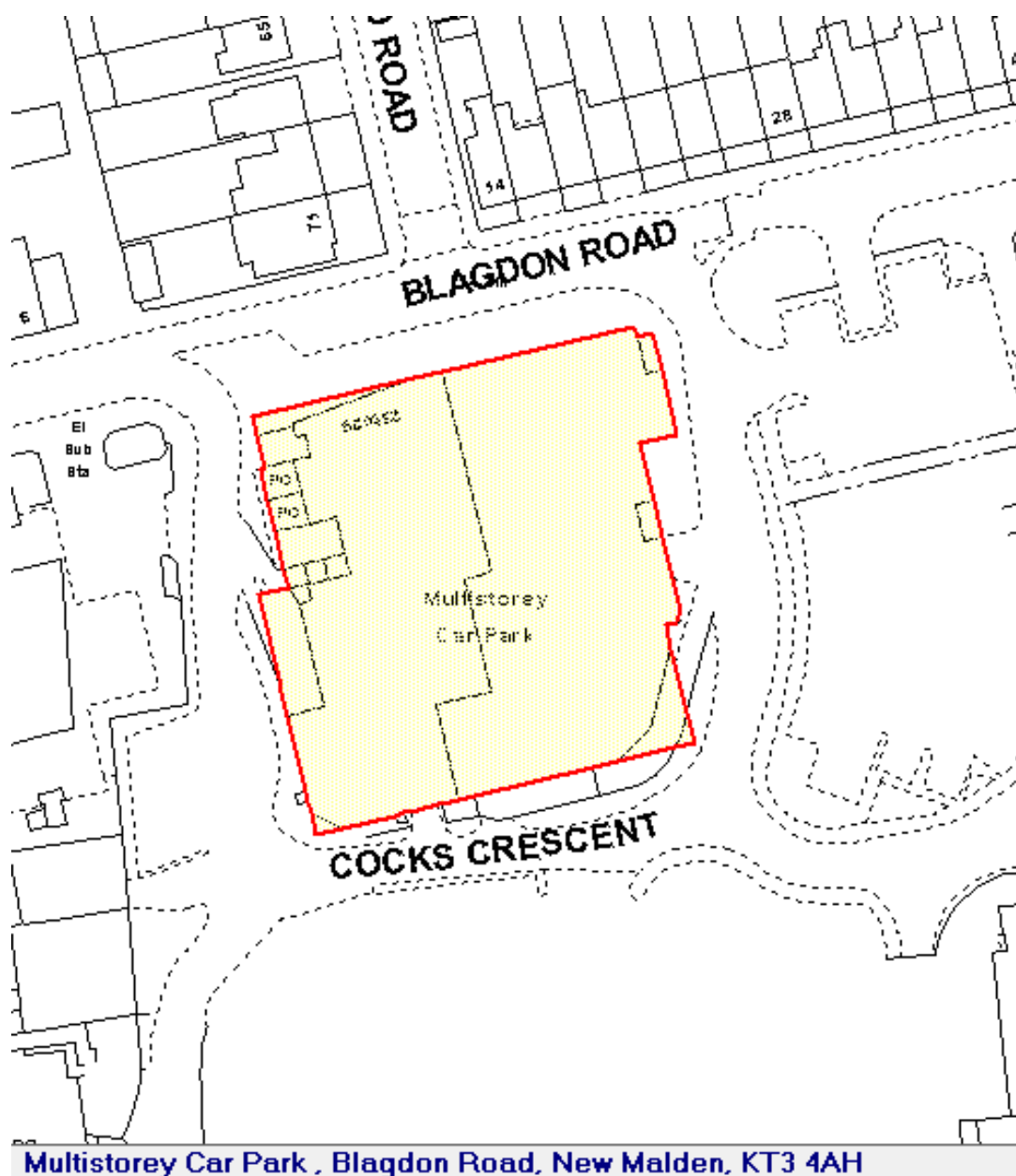
Monday to Saturday from 8:00am to 7:00pm
