The Kingston upon Thames (20 mph Speed Limit) (No. 1) Traffic Order 2021

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames made the above mentioned Order on 27 September 2021 under section 84 of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order would be to impose a speed limit of 20 miles per hour in the following roads; Coutts Avenue, Durbin Road, Sanger Avenue and The Causeway, Chessington.

**THE KINGSTON UPON THAMES (20 MPH SPEED LIMIT)

Made :- 27 September 2021

Coming into force :- 4 October 2021

The Council of the Royal Borough of Kingston upon Thames, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 84 of the Road Traffic Regulation Act 1984**(a)** as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985**(b)**, and of all other powers thereunto enabling, hereby make the following Order: -

1. This Order shall come into force on 4 October 2021 and may be cited **as The Kingston upon Thames (20 mph Speed Limit) (No. 1) Traffic Order 2021**.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any length of road specified in the Schedule to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011**(c)** when used in accordance with regulation 3(5) of those Regulations.

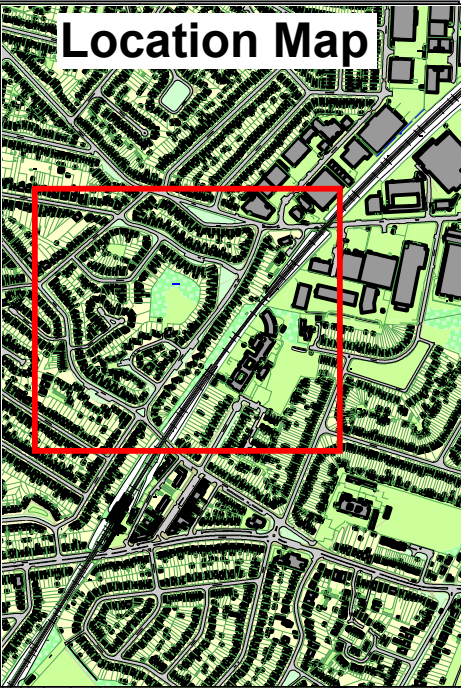
EXPLANATORY NOTE

This Order introduces a 20 mph speed limit in Coutts Avenue, Durbin Road, Sanger Avenue and The Causeway, Chessington.
