1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames propose to make the ABOVE Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The general effect of the Orders, will be to remove lengths of permit holder only parking bays and replace with waiting restrictions operating Monday to Friday 8.30am to 6.30pm outside Nos. 1, 2, 13, 23, 24, 30, 33, 40, 59 and 62 **Lingfield Avenue**, Surbiton to facilitate construction of kerb build outs and tree planting.

STATEMENT OF REASONS

We have had several reports from residents asking us to address speeding vehicles and through traffic, especially Heavy Good Vehicles using Lingfield Avenue to get access to the Recycling Centre. The scheme consists of placing a number of kerb build-outs where a tree will be planted. A Kerb Build-out is a type of Traffic Calming measure which we use to reduce speeds on our roads. This is done by reducing the width of the carriageway at various points, which will create visual impact on drivers that the road is not wide enough and they will reduce their speed and create a better environment for residents. Every effort has been made to reduce impact on residents, however, as part of this scheme 10 on-street parking spaces will be lost as a result of these changes.






