STATEMENT OF REASONS

The introduction of disabled persons' parking places is intended to provide on-street parking facilities for mobility-impaired residents to enable them to park close to their homes.

Existing disabled persons' parking places are now redundant and would be removed.

1. **NOTICE IS HEREBY GIVEN** that the Council of the Royal Borough of Kingston upon Thames propose to make the following Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹, as amended –

 - (v) adjacent No. 61a **Kingshill Avenue**, Worcester Park (in place of the existing uncontrolled footway parking bay, 2 wheels on the footway);
 - (vi) outside Nos. 30 and 32 **Knollmead**, Surbiton;
 - (vii) outside No. 7 **Melrose Gardens**, New Malden;
 - (viii) outside Park House No. 17 **Surbiton Hill Park**, Surbiton;
 - (ix) outside Nos. 55a and 57 **Westbury Road**, New Malden; and
