Spotlight on ... "Think Family!"

At this time of Covid-19 Crisis and lockdown, it is well known that across the UK and locally, referrals to Children's Social Care have fallen and vulnerable children are not all attending school at this time. Those who volunteer and work with adults are in a vital position to be our eyes and ears in the community, looking out for concerns for children and unborn babies-domestic abuse, parental mental health difficulties, learning disabilities or substance misuse concerns. Last year, a multi-agency audit looked at children and adults with mental health concerns.


