## Board Summary

On the 22<sup>nd</sup> July 2021, KSAB held their sixth virtual meeting. All Board Members agreed to the proposed Review Brief which will be conducted by Teresa Bell. The review will look at how the board works, what works well and what hasn't, its responsibilities, membership and what happens next. Teresa will be meeting (virtually) with members of the board and pulling together a report for the October Board.

Amongst other business discussed:

- The Board received the first SWL LeDeR Report (Learning Disability Mortality Review). The board acknowledged that the borough CCG had been commended across SWL for the completion of timely reviews. All those involved were congratulated.
- The Board has a statutory duty to produce an Annual Report and members were asked to provide key achievements for their organisation from 2020/21 as well as how their organisation adapted/operated during the Covid-19 Pandemic/Lockdown. Once the Annual Report is completed, it will be presented to the Health & Wellbeing Board and published on the website once agreed.
- The Board received the Q1 Safeguarding data which highlighted evidence of good partnership working.

## Spotlight on ... “National Safeguarding Adults Week 2021”

This year, the **National Safeguarding Adults Week** will take place from the 15<sup>th</sup> to 19<sup>th</sup> November 2021.

Safeguarding Adults Week is a time for organisations to come together to raise awareness of important safeguarding issues. The aim is to highlight safeguarding key issues, facilitate conversations and to raise awareness of safeguarding best practice. So we can all be better together. We hope the week will enable more organisations and individuals to feel confident in recognising the signs of abuse and neglect and recording and reporting safeguarding concerns.

The [Ann Craft Trust](#) provide information and resources every year. This year, they are focussing on the theme of ‘Safer Cultures’. Promoting safer cultures is all about how organisations and individuals can take steps to minimise harm occurring in the first instance. At the same time, it means ensuring correct policies and procedures are in place. That way, if any safeguarding concerns are raised, they can be recognised and responded to swiftly and effectively.

Celebrating and promoting this week in Kingston, we have organised daily sessions under the Subject Matter Expert Programme as follows:

- 15<sup>th</sup> November – PREVENT
- 16<sup>th</sup> November – Basic Safeguarding Awareness
- 17<sup>th</sup> November – Think Family!
- 18<sup>th</sup> November – Adult Child to Parent Violence
- 19<sup>th</sup> November – Basic Safeguarding Awareness

#### SAR Sub Group

The two ongoing SAR's are progressing, with one presenting their Final Report to the October Board following feedback from the sub-group. The group were updated on the new referrals received at the June meeting where further information was requested e.g. one will be reconsidered at the next meeting; with the safeguarding enquiry completed, it was decided the case did not meet the criteria for a SAR. A new referral was also received and it was decided and agreed by the board that it did not meet the criteria for a SAR. The next meeting is on 29<sup>th</sup> September 2021.
