## **Board Summary**

On the 24<sup>th</sup> November 2021, KSAB held their seventh virtual meeting. The Board received feedback from the KSAB Review undertaken by an Independent Reviewer, Teresa Bell. The review found there was a consistent view and understanding of where Kingston is currently from all members. However, there is an over reliance on certain members and a lack of funding compared to other SAB's. The review recommended recruitment of an Independent Chair who will be impartial and with links to other networks; review core partner contribution and establish a realistic budget; review of all sub-groups; Development Day to be arranged to refresh the Board Strategy and develop a Business Plan.

Amongst other business discussed KSAB received feedback of the events held during the 2021 National Adults Safeguarding Week which included sessions on Safeguarding Awareness, Think Family!, Prevent and Adult Child to Parent Violence; Guidance on SAR Principles will be used in conjunction with the London multi-agency safeguarding adult's policy and procedures and has been designed with the aim of standardising how SARs are conducted and will be incorporated into the SAR Policy; a Covid-19 Safeguarding Audit was carried out to review how safeguarding activity was affected by the pandemic in order to inform our future responses to people with safeguarding needs; the latest adult safeguarding performance data for the last quarter was received; a Final SAR Report was received for approval.

### "National SAB Awards 2021"

This year, the National Safeguarding Adult Network held the first **National SAB Awards,** which Kingston Safeguarding Adults Board gave their support to. SAB's were invited to submit their nominees to the following categories:

- <u>Empowerment Champion</u> someone/team who demonstrated empowering individuals
- <u>Prevention Champion</u> someone/team who demonstrated or acted to prevent abuse or neglect
- <u>Proportionality Champion</u> someone/team who demonstrated being balanced in their approach to ensure the least intrusive response
- <u>Partnership Champion</u> someone/team who demonstrated working in partnership
- <u>Accountability Champion</u> someone/team who demonstrated keeping others accountable, including themselves
- <u>Protection Champion</u> someone/team who demonstrated protecting adults at risk
- <u>Lifetime Award</u> includes anyone who has demonstrated more than 20 years' experience in Safeguarding Adults
- <u>Innovation</u> includes all areas where someone/team has been creative and set new ways of working with adults at risk

The Network agreed that each category winner would receive a certificate, trophy and local and national recognition. Along with offering their support, KSAB submitted two nominations for the awards, who were previous recipients of a Kingston Safeguarding Practice Award (KiSPA) from KSAB. The nominees were:

Blue District Nursing Team, Your Healthcare – Empowerment Champion 3 Police Officers, Kingston Police – Protection Champion

The Board would like to congratulate both teams on their nominations. However, we are pleased to announce the 'Blue District Nursing Team' won their category and were named "Empowerment Champions".

Jo Maulding, Lead for Community Nursing at Your Healthcare said "We would like to thank the KSAB for nominating our service for this award. We were delighted to receive the award and gain recognition for the hard work and expertise in the Community Nursing Team and their ability to respond to complex safeguarding concerns".
