### PROPOSED DISABLED BAYS and PROPOSED REVOCATION OF DISABLED BAYS – VARIOUS LOCATIONS (TMO – KingMap0075)

1. **NOTICE IS HEREBY GIVEN** that the Council of the Royal Borough of Kingston upon Thames made the following Orders on 30 January 2023 under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984<sup>1</sup>, as amended –
  - (a) **The Kingston upon Thames (Charged-For Parking Places) (Amendment No. 78) Order 2023**; and
  - (b) **The Kingston upon Thames (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 78) Order 2023**
2. The principal objectives of the Orders are; (a) to introduce disabled bays to provide a parking facility for disabled persons where a high level of parking makes reasonable means of access difficult, and (b) revoke those parking bays that are no longer required;
3. The general effect of the Orders will:-
  - (a) provide new disabled person's parking places, 6.6 metres in length, in which vehicles displaying a disabled person's badge may park at any time, at the following locations:-
    - (i) outside No. 131 **Chantry Road**, Chessington;
    - (ii) outside Nos. 88 and 90 **Clifton Road**, Kingston (in place of the existing permit holder only parking bay);
    - (iii) outside No. 172 **Ellerton Road**, Surbiton;
    - (iv) adjacent No. 61a **Kingshill Avenue**, Worcester Park (in place of the existing uncontrolled footway parking bay, 2 wheels on the footway);
    - (v) outside Nos. 30 and 32 **Knollmead**, Surbiton;
    - (vi) outside No. 7 **Melrose Gardens**, New Malden;
    - (vii) outside Park House No. 17 **Surbiton Hill Park**, Surbiton;
    - (viii) outside Nos. 55a and 57 **Westbury Road**, New Malden; and
    - (ix) outside Nos. 79 and 81 **Woodgate Avenue**, Chessington
  - (b) revoke existing disabled person's parking places at the following locations
    - (i) outside No. 122 **Chantry Road**, Chessington;
    - (ii) outside Nos. 69 and 112 **Chestnut Grove**, New Malden (two locations);
    - (iii) adjacent No. 311 **Malden Road**, New Malden; and
    - (iv) outside No. 16 **St Leonards Road**, Surbiton,
