I am delighted that we have found some creative ideas we are planning on testing out. I hope to be able to give an outline of this in the next newsletter.

Board Summary

On the 20th April 2023, KSAB held a virtual meeting. This SAB continued the focus on learning from recommendations from SARs. The April Board in particular focussed on Transitional Safeguarding which was recently highlighted in a Tri-Borough SAR. A summary of the Tri-borough SAR was given to board members along with the recommendations.

The Board received a presentation by Roberta Evans, Associate Director for Family & Youth Support – Early Health on Transitional Safeguarding. The presentation explained the gaps in transition with potentially 70% of children transitioning without adult social care support. Many young people with risks of exploitation and violence move into adulthood without any ongoing support. A protocol has been established along with a Panel to review high risk young adults to consider a multi-agency safety and risk management approach.

The Board also received a presentation by Sade Harvey, VASA Co-ordinator on the VASA (Vulnerable Adults Supported into Adulthood) Panel. The panel has strong membership from agencies across Kingston & Richmond including colleagues from the Police, Community Safety Partnership, and Achieving for Children, Adult Social Care, Adolescent Social Care, Contextual Safeguarding, Health Services and more.

The board continued its discussions from the January meeting about how to best incorporate those with lived experience. This will be worked on over the coming months.

There was a briefing on Safeguarding Asylum Seekers, as well as an update on the early intervention work regarding self-neglect. Then the Board had a session on looking at how it can gain greater assurance from data and intelligence. There were discussions in relation to: safeguarding outcomes in Care Homes and the risks relating to hospital discharge. A current standing item for the Board is to keep a watchful eye on the impact of the Cost-of-Living crisis on safeguarding issues.

The next scheduled KSAB is on 13th July 2023 commencing at 1.00pm

SAR Sub Group

At the last SAR Sub-group meeting in March, the Recommendations from a Tri-borough SAR were discussed and actioned.

The draft Terms of Reference for a new SAR were agreed. A report will be prepared for the next subgroup meeting on issues identified/raised in relation to cases that had not gone to SAR but had additional learning to be discussed.

No new referrals for consideration were received.

The next meeting is scheduled for 26th June 2023 and all new referrals should be submitted in advance and sent to sar.referral@kingston.gov.uk .
