# **Board Summary**

On the 13<sup>th</sup> July 2023, KSAB held a virtual meeting. This SAB continued the focus on learning from recommendations from SARs. The Board in particular focussed on how learning has been embedded from two of Kingston's SARs as well as learning from SARs in other boroughs.

The Board received a presentation by Sarah Brown, Service Development & Commissioning Lead for Public Health on Drug and Alcohol Deaths. A Panel was set up in 2022 for members to review drug and alcohol-related deaths within the borough and to examine the involvement of a range of services in the deceased's life. The aim of learning lessons to improve future practice and therefore reduce the number of substance misuse-related deaths. A few key themes emerged from the deaths reviewed and in response to these emerging themes, actions are already underway.

The Board also received a presentation by Scott Bacon and Helena Wright from Healthwatch Kingston and provided an update on the Outcomes from the Making Safeguarding Personal project. The MSP Annual Report identified recommendations for safeguarding practice and learning; improvements required in offering advocacy and discussing outcomes, along with acknowledging positive practice in outcomes for Adults at Risk.

The board discussed its structure, roles, and governance of the KSAB. The structure of KSAB is to move from numerous sub-groups to work streams. The board were briefed on how the format of the next Annual Report will be changed to focus on making it more interesting and how this is presented to the public. There was discussion on the change in model used by police 'Right care Right person' and the impact of this to safeguarding. There was a focus this month on data relating to drug and alcohol deaths and although there is a gap in this data, there is ongoing work to pull this data out and improve recording of this on safeguarding forms. A paper was shared on sharing resources across SWL. The Comms Sub-group shared the Communications Work Plan and the board were briefed on the updated KSAB Risk Register

The next scheduled KSAB is on 19th October 2023 commencing at 1.00pm

# "Vulnerable Adults Supported into Adulthood Panel"

The VASA Panel is a partnership approach between organisations in the Kingston and Richmond boroughs to consider cases of adolescent who remain at high risk of contextual harm and exploitation despite previous intervention efforts at the point of transition in to adulthood or up to 25 years. The purpose of the panel is to provide advice, guidance and signposting that prevents, manages or reduces contextual harm and exploitation for eligible adolescents.

Members of the panel are made up of representatives from Health, Housing, Safer Kingston Partnership, Contextual Safeguarding, Probation, Leaving Care, Adolescent Safeguarding, Adult Social care, Youth Justice, Police, Way2Work. They support the panel by contributing towards discussions, providing intelligence and offering advice and guidance.

### **VASA Award - Bespoke Fund**

The VASA Award is a bespoke fund that can be used towards items and opportunities that aim to prevent further risks and harm. The VASA panel will award funds to support 18-25 year olds in Kingston and Richmond who are known to the VASA panel, IOM or the core support services.

Delivery providers can apply for one-off awards to deliver group projects and community improvements that will reduce risks for the 18-25 cohort. Examples are accredited course fees up to Level 3 (A-level equivalent); tools, equipment or uniforms for a job; childcare fees to attend activity/interview/training; household appliances; clothing; groceries; passport or provisional driving licence application or test; UCAS application; self-care expenses; positive activities; community projects/events.

The panel meet on the **first Wednesday of every month**, from 10am to 1pm.

Criteria for all referrals will be considered for adolescents who are aged between 18-25 years; at risk of sexual exploitation, criminal exploitation (including County Lines), or high risk of harm; Transition cases (3 months before 18<sup>th</sup> birthday) and have not been discussed on any other panel or agreed transfer.

The panel will consider any referral made that meets the criteria. The referring person or agency will be invited to attend the meeting to present their referral. The panel will confirm sign posting options or different panels for cases that do not meet the VASA panel criteria.

All completed referrals must be received at least **five** working days before each panel and emailed to <u>kingstonandrichmondvasa@kingston.gov.uk</u>.
