## **Board Summary**

On the 19<sup>th</sup> October 2023, KSAB held a virtual meeting. The board welcomed Daniel Morris, who has been appointed as the New Business Manager for the KSAB. Welcome to Kingston Daniel!

The Board received a presentation by Fergus Keegan, Director of Quality at the ICB; Sam Morrison, Acting Director of Adult Social Care; Ian Cameron, Detective Superintendent, from Metropolitan Police on the impact of Right Care, Right Person (RCRP) from a health and police perspective. RCRP is an operational model that provides guidance on the way the MPS responds to health related calls and is aimed at making sure the right agency deals with health-related calls, instead of the police being the default first responder where there is a concern about a person's physical or mental health. This model is due to go live on 1<sup>st</sup> November 2023. The SAB continued the learning with focussed papers on Self-Neglect by Su Fitzgerald, Housing & Cost of Living Issues by Amanjit Sandhu and Lorna Brooke, and Winter Pressures by Peter Warburton and Francesca Butcher.

The board received an update on the imminent Inspection of Adult Social Care by CQC and the impact this will have on the SAB. The inspection date is yet to be confirmed. The SAB Chair also confirmed the 2022/23 Annual Report had recently been presented to the Health & Wellbeing Board and will be ready for publication shortly. Several members shared their organisations data and intelligence information on what should we be concerned about, and how do we know we have made a difference? The Comms Sub-group shared plans for National Safeguarding Adults Week – see the 'Spotlight On...' section for more information. The Training Subgroup discussed links with the voluntary sector and if training could be provided for Trustees to ensure they get a sense of compliance.

# National Safeguarding Adults Week 2024 #SafeguardingAdultsWeek

This year, National Safeguarding Adults Week will take place from the 20<sup>th</sup> to the 24<sup>th</sup> November 2024. This year, the focus is on how you can prioritise the welfare and wellbeing of yourself and others.

It's an opportunity for organisations to come together to raise awareness of important safeguarding issues. The aim is to highlight key safeguarding issues, start conversations and raise awareness of safeguarding best practice. Each day, there will be focus on a different safeguarding theme which relates to how individuals and organisation can safeguard themselves and others.

National events for the week are as follows:

- Monday 20<sup>th</sup> November, 10-11am "Who's looking after the people looking after the people" - This session is about how individuals can look after their own wellbeing when supporting others.
- Tuesday 21st November, 10-11am "Let's Start Talking Taking the Lead on Safer Cultures in Your Organisation" This session will discuss what makes a safer culture and provide participants with a space to reflect on the culture within the organisation.
- Wednesday 22<sup>nd</sup> November, 9-4pm "Looking after Yourself & Others: Ann Craft Trust Safeguarding Adults Conference" – informative keynotes and workshops.
- Friday 24<sup>th</sup> November, 10-11am "Developing Boccia England's Your Wellbeing Toolkit" – learn about the creation of the wellbeing toolkit.
