*The Kingston upon Thames (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 49) Order 2021; and The Kingston upon Thames (Charged-For Parking Places) (Amendment No. 49) Order 2021.*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames on 9<sup>th</sup> August 2021 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, which will come into force on 16<sup>th</sup> August 2021, will be;

- (a) to introduce a disabled persons' parking place in Victoria Avenue, Surbiton – outside No. 6 (in place of an existing 'permit holders only' parking space); and
- (b) to introduce double yellow line "at any time" waiting restrictions in Knightwood Crescent, New Malden (on the south and west sides, from opposite No. 38 to opposite No. 52).

*Please note;* with items (a) and (b) above along with items on a public notice dated 21<sup>st</sup> January 2021, all items proposed on the public notice dated 1<sup>st</sup> October 2020 (ref. KingMap0046) are now effective.

3. Due to the current Coronavirus pandemic, the made Orders and plans cannot currently be inspected at Guildhall 2 until the building is open again for normal business. However, the following alternative arrangements have been made;

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or any relevant regulations made thereunder have not been complied with in relation to the Orders may make application for the purpose to the High Court by 20<sup>th</sup> September 2021.

### **STATEMENT OF REASONS**

The introduction of a disabled persons' parking place is intended to provide on-street parking facilities for mobility-impaired residents to enable them to park close to their homes.

In Knightwood Crescent, New Malden, the introduction of a double yellow line "at any time" waiting restriction is intended to reinforce rules 242 & 243 of the Highway Code with the aim of further protecting safety and access for all road users by highlighting, and enforcing, locations where a vehicle or trailer may otherwise be parked in a dangerous position or cause an unnecessary obstruction of the road. This restriction is introduced in response to a petition from local residents.

  - (3) any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

  - (1) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2018 shall have effect as though for the map tile attached to that Order and specified in column 1 of the Schedule to this Order, there were substituted the map tile attached to this Order and specified in relation thereto in column 2 of the Schedule to this Order.
  - (2) The substitution of any map tile referred to in Article 3.1 of this Order will have the effect of revoking any provision provided or designated by a previous version of that map tile and not incorporated into the latest version.

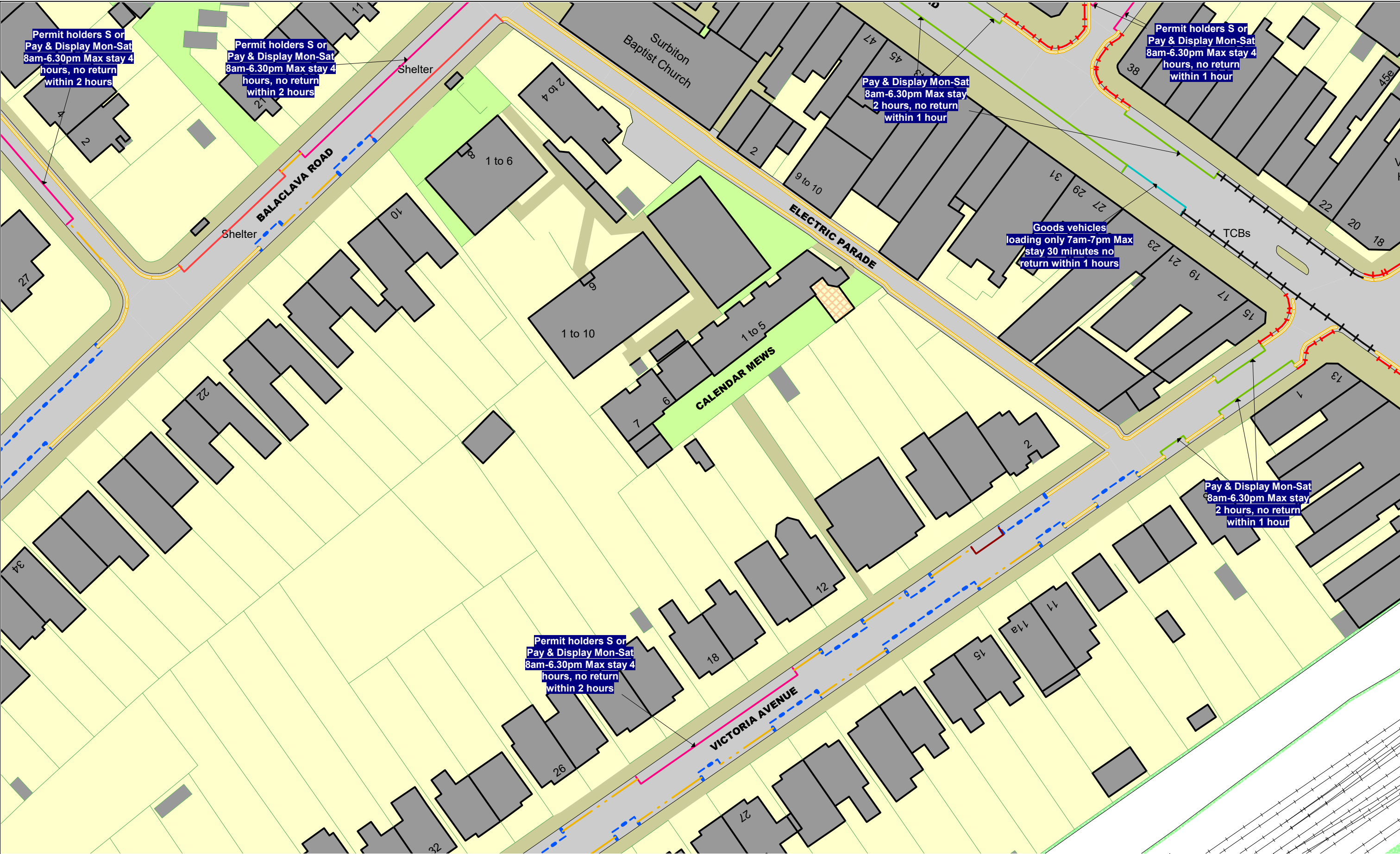
